No. 162A of 2020 — COVID-19 (Prevention and Control) (Fees) Regulations.

*COVID-19 (Prevention and Control) (Fees) Regulations***SAINT LUCIA**

STATUTORY INSTRUMENT, 2020, No. 162A

[ 15th October, 2020 ]

In exercise of the power conferred under section 65(2)(c) and (k) of the COVID-19 (Prevention and Control) Act, No. 9 of 2020, the Minister responsible for health makes these Regulations:

**Citation**

1. These Regulations may be cited as the COVID-19 (Prevention and Control) (Fees) Regulations, 2020.

**Application**

2. These Regulations apply to a visitor, returning national or other category of persons arriving in Saint Lucia who are placed in quarantine.

**Fees at quarantine facility**

3.—(1) The fees for quarantine at a quarantine facility are as specified in Part A of the Schedule.

(2) Notwithstanding subregulation (1), a child pays fifty per cent of the fee payable by an adult in any fee specified in Part A of the Schedule.

(3) Fees for quarantine under subregulation (1) must be paid directly to the quarantine facility.

**Fees for electronic monitoring device**

4.—(1) The fees for an electronic monitoring device are as specified in Part B of the Schedule.

(2) Fees for an electronic monitoring device under subregulation (1) must be paid to the Ministry responsible for health or any supplier that the Ministry designates.
